## Notes from our August 10, 2025 Church Council Mtg.

Present: Ted M./today's moderator, Annie C., Ann G., Richard P., Randy G., Virginia W., Wendy P., and guests Sherrill H. (Apartheid Free) and Patricia D. (painting church)

Ted opened the meeting with a prayer; the notes from our June 8th CC meeting were approved.

### New Business

Sherrill is here to help figure out a motion to present at our Aug. 24th informational meeting on our church becoming an **Apartheid Free Community**. This Apartheid Free movement was initiated by the American Friends Service Committee, and numerous UCC churches have already signed on (and it was brought up 2 yr. ago at the national UCC Synod). Various materials presented on the subject. Much discussion. The general consensus was to give a clear, simple explanation of what is being asked with minimal handouts, with the simple, clear handout from Apartheid Free being our choice. (We Affirm, We Oppose, We Declare, We pledge..)

Ted presented the following motion, which was then approved by the CC:

#### **Apartheid-Free Motion (for discussion August 24 and vote September 7)**

It is moved that the First Congregational Church of Ashfield, UCC adopt the following pledge in support of the Apartheid-Free network:

We affirm our commitment to freedom, justice, and equality for the Palestinian people and all people;

We oppose all forms of racism, bigotry, discrimination, and oppression; and

We declare ourselves and apartheid-free community, and to that end,

We pledge to join others in working to end all support to Israel's apartheid regime, settler colonialism, and military occupation.

In light of our congregation supporting the rights of others, Randy notes that we have not yet posted a **Land Acknowledgement plaque**. Words of the proposed plaque read. Members of the CC approve of this proposed land acknowledgement. Randy to bring up at this week's M&SJ meeting.

**One unanswered question:** What does signing on to this pledge mean for our congregation? "We pledge to join others in working to end all support to Israel's apartheid regime, settler colonialism, and military occupation." Sherrill and M&SJ to follow up.

**Old Business / Reports**

**Trustees:**

Discussed the need to repaint Friendship Hall / the hallway, in particular covering up the red. Randy notes that the color should be something that can (visually) handle the scratches made by the comings and goings of the food pantry carts saying "Nothing lighter than the color of wainscoting in the Green Room." Annie suggests removing the bulletin board in Friendship Hall by the kitchen, painting that wall, and, if needed, mount that bulletin board in a more accessible place.

Need for painting the outside of the church discussed, especially the belfry. Alan S. has offered to paint the area around the side entrance of the church. Per Richard, Jeff B., our custodian, has access to good quality, less expensive paint.

Old Friendship Hall Curtains to be removed and discarded. No need for new curtains in that room. (Patricia to follow up.)

**Treasurer/Office Manager:** Just updated software; changed from Quick Books to Quicken. Virginia notes that one needs to update software frequently!

**Deacons:** Childcare to be offered starting 9/14; will be held in downstairs Sunday School room. Storage space for Food Pantry discussed. (Randy says that the Food Pantry is looking into renovating the shed. The temperature will be controlled within a specific temp range to allow for the storage of canned items. May need to build an additional small shed to hold church lawnmower, etc.)

**M&SJ:** In addition to talking about the Land Acknowledgement in this week's M&SJ meeting, they will also discuss putting up the new sign to go on the front of the church. Randy to connect with Chris Haddad about removing the faded Immigrants Welcome sign and put up the new sign welcoming all - front right of the church.

**Stewardship:** No info. Ted to send initial 2026 budget to Rev. Bert, Rev. Ann H., and Rev. David (current members of the Stewardship Committee) with the hopes of getting things going.

**ACT:** picnic Thurs. Aug. 14, rain or shine! Ahmadi family in attendance.

**Fall Festival:** meetings continue

**Pastoral Review Committee:** to meet shortly

**Piano Committee:** John Y., Virginia W., Liz VanG., Margery H., Gerard McG...

Have been looking at pianos. Possibility of renting one (\$300 month) or buying one (\$12,000 once repaired.) Liz VanG to be in charge of fundraising. Piano will be a bit longer than current one, but workable per Margery...
